The Uniforms for the 2026 PHCMDC Spring Term will be ordered within 12-14 weeks before the Bermuda Day Parade on May 23<sup>rd</sup>, 2026. This Uniform will be used from May 22<sup>nd</sup>, 2026, to May 21<sup>st</sup>, 2027, for performances PHCMDC is requested.

The total cost you are required to pay for your uniform is based on the section that you have signed up to participate in. As of November 3<sup>rd</sup>, 2025, you will be provided with approximate costs on the Uniform Information Chart, with final prices to be confirmed on or before January 31<sup>st</sup>, 2026. Each member will be required to pay the initial deposit of \$150 and sign this contract in agreement to pay the balances in line with the deadlines provided.

**FOR ALL 2026 MEMBERS:**
